

# **Platinum Print Ltd Modern Slavery and Human Trafficking Statement**

#### Introduction

This statement relates to actions and activities undertaken by Platinum Print Ltd. We are committed to preventing slavery and human trafficking in our business activities and the steps we have put in place with the aim of ensuring that there is no slavery or human trafficking in our own business and supply chains. We all have a duty to be alert to risks, however small. Staff are expected to report their concerns and management to act upon them.

## Organisational structure and supply chains

This statement covers the business activities of Platinum Print Ltd which are as follows: The design, production and supply of printed items from either Digital or Litho processes from within the site based at Park House, Hookstone Park, Harrogate HG2 7DB. Materials sourced are supplied from an approved suppliers list which is reviewed annually.

## **High Risk Activities**

Platinum Print Ltd are not aware of any activities considered to be at high risk of modern slavery or human trafficking.

Responsibility for the Company's anti-slavery initiatives is as follows:

- 1.1 Policies: Anthony Wyvill is responsible for creating and reviewing policies. The process by which policies are developed is through professional advice from The British Printing Industry Federation and looking at best practice and adapting the needs of the company.
- 1.2 Risk assessments: Katie Rogers is responsible for risk assessments in respect of human rights and modern-day slavery by a process of recruitment and the company appraisal system.
- 1.3 Due diligence: Anthony Wyvill is responsible for due diligence in relation to known or suspected instances of modern slavery and human trafficking.

## **Training**

To ensure a good understanding of the risks of modern slavery and human trafficking in our business and supply chains, the Company requires all staff to read through this statement and accompanying fact sheet.

#### **Policy**

The Company is committed to ensuring that there is no modern slavery or human trafficking in our business or our supply chains. This Statement affirms its intention to act ethically in our business relationships. The Company encourages all its workers, customers and other business partners to report any concerns related to its direct activities or its supply chains. The Company undertakes due diligence when considering taking on new suppliers, and regularly reviews its existing suppliers. The Company's due diligence process includes building long-standing relationships with suppliers and making clear our expectations of business partners
